During the year ended June 30, 2017, the Palm Beach County Food Bank, Inc. served 170 organizations through 4 programs. It distributed almost 5 million pounds of food to more than 100 agencies on the front-line of hunger relief from Tequesta to Boca Raton and from Belle Glade and Pahokee to the Coast. In addition, the Food Bank operates Food4OurKids which distributed almost 15,000 meals at 32 partner sites during the summer with weekly backpacks of food, helped more than 6,200 individuals receive \$3.5 million of federal food benefit assistance, and graduated almost 900 from Nutrition Driven, a nutrition education program in partnership with the Palm Beach County Extension/University of Florida Institute for Food and Agriculture Sciences.
